



# Introduction

## What is *Improve your Skills: Reading for IELTS 6.0–7.5*?

*Reading for IELTS* is part of the *Improve your Skills* exam skills series: three preparation books which cover all aspects of the IELTS exam for students aiming for an IELTS band score of 6.0–7.5. This course aims to develop the key reading skills, and language and exam techniques for the IELTS Reading paper.

The course can be used together with the other books in the series: *Writing for IELTS 6.0–7.5* and *Listening & Speaking for IELTS 6.0–7.5*.

## How do I use *Improve your Skills*?

You can use any of the books in this series either in class or to study on your own. The course will guide you through the activities step by step, so you can use this book with or without a teacher.

If you are studying as part of a class, your teacher will direct you on how to use each activity. Some activities can be treated as discussions, in which case they can be a useful opportunity to share ideas and techniques with other learners.

## How is *Improve your Skills: Reading for IELTS* organized?

The course is made up of 10 units, each aimed at developing a particular reading skill (e.g., *scanning*). Every unit is themed around a commonly occurring topic from the IELTS exam. Each unit consists of:

- **Skills development:** explanation, examples and tasks to develop and practise relevant reading skills both for general use and the exam. Each skill is broken down into simple stages with reference to why each skill is important for IELTS.
- **Vocabulary:** useful vocabulary for the IELTS exam.
- **Exam focus and practice:** focus on how each skill relates to the exam, followed by authentic IELTS-style tasks for real exam practice.

There are also *Skills tip* boxes throughout the book containing useful information and ideas on how to approach the different exam reading tasks.

## How will *Improve your Skills* increase my chances of exam success?

### Skills development

The skills sections form a detailed syllabus of core reading skills which are useful both in the exam and in everyday life – reading for specific information and understanding attitude and opinion, for example. People often do these things in their own language without noticing, so it can take some practice to perform these actions in another language. Learning and understanding vocabulary and grammar can take priority in the classroom, and these very important skills can often get ignored.

### Language input

Each unit includes useful vocabulary and phrases for the exam. In *Improve your Skills: Reading for IELTS*, you will find a wide range of topic vocabulary and ideas to ensure that you are well prepared when you reach the real exam.

## Exam technique

In any exam, it is important to be prepared for the types of tasks you are likely to be given, and to have methods ready to answer any particular question. The *Skills tip* boxes give short, simple advice about different types of questions, as well as study skills and how to effectively use the skills you have learnt. The course covers every question type that you will face in the IELTS exam.

## How is the IELTS exam organized and where does reading fit in?

The IELTS exam consists of four papers: *Reading*, *Writing*, *Speaking* and *Listening*. The *Reading* paper consists of three reading passages with tasks (a total of 40 questions) and lasts one hour.

## What does each task consist of?

The authentic reading passages are taken from a range of sources and aim to test your reading ability in a number of ways. The range of questions used in the exam are:

- multiple-choice questions
- short-answer questions
- sentence completion
- notes, flow chart, table completion
- labelling a diagram/map
- summary completion with and without wordlists
- classification
- matching information to paragraphs
- matching paragraph/section headings
- identification of information – True/False/Not Given
- identification of writer's views/claims – Yes/No/Not Given

You need to be comfortable with all of the question types, though there will probably only be a selection of them in the exam.

This course will develop your understanding of and strategies for answering all of the above question types, as well as the techniques you will need to use when reading, such as scanning and skimming.

## How is it assessed?

The Academic Reading component is weighted, which means the number of correct answers required to achieve a particular band score may vary from exam to exam. As a rough guide, to achieve a score band 7, you should aim for at least 29 or 30 correct answers.


As you do different reading passages in the book, the number of correct answers in each will probably be different. This reflects the nature of the IELTS exam as some passages may appear to be easier or more difficult than others.

- A** Celebrities and the media have a distinctly 'love-hate' relationship and, whilst they recognize their mutual dependency, striking a balance between their respective interests is an on-going challenge for both groups.
- B** In the worlds of sport, entertainment and politics, celebrities depend on the press, social media, photographers and radio and television to raise their public profile, and afford them the visibility essential to success in their highly competitive professions. For example, top-class sports celebrities rely on income from commercial sponsorship to pay for expensive coaching, fitness and training facilities. In the entertainment business, glamorous award ceremonies and opening nights of much-anticipated films not only provide the cast with what is undoubtedly an enjoyable and well-deserved celebration of their success, but also an opportunity for valuable exposure to their fans as well as to influential figures in their own industry.
- C** At the same time, sales revenues from advertising and audience ratings are boosted by stories about famous figures, which range from casual gossip to carefully researched information, depending on their purpose and target audience.
- D** The conflict between these apparently compatible interests lies in deciding how much access the media should have to the daily lives of the famous and the amount of privacy any individual should be entitled to.
- E** This clash has been intensified in the first two decades of the 21<sup>st</sup> century by recent developments in communications and digital science. There can be little doubt that the dramatic expansion of online social media has made it possible to spread rumours, true or false, instantly across the globe. This has significantly increased the power of the press to enhance or damage the reputation of any public figure. Due to advances in high-tech photographic equipment, it has become easier than ever for photojournalists to intrude on the private lives of well-known personalities without their knowledge or agreement. This has led, on many occasions, to legal battles between the media and celebrities to determine whether newspapers should be entitled to publish images of high-profile personalities taken when they are not appearing in public. Another example of how the press has used dubious methods to obtain information about famous personalities is *phone hacking*, or listening in to private phone calls, which has also resulted in a number of court cases.
- F** In court, a judge may decide what the press is allowed to publish about well-known figures by taking 'public interest' into account. In this case, 'public interest' does not simply mean the number of people who would like to know more about the private lives of high-profile personalities, but how much society, as a whole, would benefit from this information.

## Exam skills

### Matching headings questions

In these questions you are asked to choose from a list of headings (numbered i, ii, iii, ...) that refer to the main meaning of a paragraph or section of the text marked with letters (A, B, C, ...). There will be more headings than there are paragraphs to match.

### Skimming

To answer these questions you will need to find:

- the parts of the text that summarize the main idea of each paragraph or section.
- related or similar words in the headings (e.g., *famous figures*, *press*, *needs*, *conflicting*).

To identify the main idea of a paragraph you can skim the text, without looking for detailed information.

- Look for key topic words in the paragraph (e.g., *celebrities*, *media*).
- Find words that are repeated or connected with each other (e.g., *love*, *need*, *demands*, *hate*, *conflicting*).

## Exam skills

### True/False/Not Given questions

This type of exam question asks you to decide whether a statement in the question:

- agrees with the information in the reading passage.
- does not agree with the information in the reading passage.
- is not mentioned in the reading passage.

Remember that your answer should be based only on the information in the text, not on what you already know. You can use the following technique to find the answers to True/False/Not Given questions.

- 1 Look for key words in the statement in the question.
- 2 Look for similar words or phrases in the passage to find the section that refers to the statement.
- 3 Decide whether the statement matches the information in the text.

## Skills

Be very careful when you are checking to see whether information is false or not given.

- When the information is not given, you will not find any information about this topic in the reading passage.
- When the information is false, this may be indicated by a negative, a comparative or a conditional statement in the text.

- Remember that not all negatives use a simple 'no', 'not' or 'nobody'. Expressions like *instead of, having failed to, without + [...ing]* can also indicate a negative.
- False information may also be found in parts of the text that contain comparisons. Make sure you check these, e.g., *Screen celebrities are less likely to appear in the media than sports stars.*
- Conditional sentences may also be indicators of false information. Compare the tenses of the verbs in the question statements with the verbs in the text to make sure they have the same meaning, e.g., *is/may be, can/could, saw/might have seen.*

### Skills

When you are looking for the correct ending for the sentence, you should look for:

- grammatical agreement – ask yourself if the ending is grammatically possible (e.g., Is the verb in the same tense? Do the subject and the verb agree? Is the sentence structure complete?).
- endings that cannot be correct because they are grammatically impossible.
- meaning – make sure that the second part of the sentence is on the same topic as the first part and check that it follows logically.

## Reading Passage 1

You should spend 20 minutes on questions 1–14, which are based on Reading Passage 1.

### Social Media Privacy: A Contradiction in Terms?

*This article is by Naomi Troni, global CMO of Euro RSCG Worldwide.*

- A** Never in the course of human interaction have so many shared so much about themselves with so many others — and with so little apparent concern for their privacy. Was it really just a generation ago that people kept all but their most basic information under virtual lock and key? Today, we happily share our date and place of birth, name of our first pet, mother's maiden name, favourite movie or book, favourite colour, first school teacher — and myriad other snippets of information required by online services as part of their security procedures.
- B** The basic premise behind this information-sharing is nothing new. Consumers have long handed over a little personal information in exchange for services such as banking and finance, utilities and healthcare. The big difference now is that the information is digitized and accessible online — and we're handing it out to virtually anyone who asks, regardless of how briefly the business has been in existence. Of even greater concern to many is the amount and variety of information being gathered about us *without* our explicit permission. Whereas retailers and others used to tweeze out information gleaned through loyalty cards, prize draws and catalogue mailing lists, now these old standbys have been massively augmented by customers researching and purchasing online, leaving in their wake a digital trail of cookie crumbs detailing their needs, tastes and desires.
- C** And then there's social media. If this isn't the Holy Grail\* for marketers, it's difficult to imagine what would be. In this thoroughly 21<sup>st</sup> century communications channel, old notions of privacy simply do not apply; sharing personal information, experiences and opinions is the whole point of the service. And, wonder of wonders, consumers don't only provide it willingly — they provide it for free! Sure, some people take the precaution of limiting access to their Facebook or Google+ pages, but even these people typically are eager to share their thoughts via comment sections on news sites, reviews on retail sites and in branded clubs and forums.
- D** With all the time we spend online and all the forums we frequent, it's no wonder most of us have grown accustomed to doling out little snippets of personal information with barely a second thought. It helps that we rarely are asked to hand over a whole stack of personal information in one massive data transfer; that would be too much trouble and might provoke too much anxiety. Rather, we routinely hand it out a bit at a time.
- E** Anybody over the age of 30 likely will remember that in the early days of mainstream Internet, 10 to 15 years ago, consumers were wary about handing over private information. A 2001 UCLA report, for instance, found high levels of consumer concern over online privacy in general and credit card security in particular.

- F** Since then hundreds of millions of people have come online and become regular users of commerce sites and social media. Early concerns about online privacy have been sidelined by the desire for more speed, more convenience, more choice and more great deals. Familiarity has bred complacency and even foolhardiness; we've all heard about people uploading pretty much everything, including the most intimate words and images.
- G** Now, after a decade of consumers feeling increasingly free-and-easy with their personal information online, we are seeing signs of a new wariness setting in. In a Euro RSCG global survey conducted among 7,213 adults in 19 countries, we found that 55% of respondents are worried that 'technology is robbing us of our privacy'; the figure was above 60% in a number of countries, including the United States and China. Similarly, 61% overall agreed 'People share too much about their personal thoughts and experiences online; we need to go back to being more private.'
- H** And it's not just snooping companies and hackers that consumers fear. Nearly half the sample (47%) — and a majority of millennials\* — worry that friends or family will share inappropriate personal information about them online. Around one-third overall already regret posting personal information about themselves.
- \* **Holy Grail** — a desired ambition or goal (in Christian tradition, the cup used by Jesus at the Last Supper with his followers)
- \* **Millennials** — people born between 1982 and 2000






## Skills

### Scanning for information

When you scan a text for specific information you do not need to read every word or line from left to right. Once you have decided what kind of information you want, you can let your eye move around the text and search for the features that are characteristic of that particular information. For example, you would look for *capital letters* for names of people and places, *symbols* and *numbers* for percentages, statistics and dates. Technical terms may be in *italics* or inverted commas ('...').

#### Computer Technology in the Workplace

For many forward-looking companies, the office is no longer perceived as an indispensable base for work and business, and the effectiveness of the traditional 9–5 working day is increasingly being challenged.

- A** For years, employers have been aware of employee engagement\* and retention issues in their workplaces. These organizations have engagement policies that typically address engagement for the organization under one policy, without any differentiation for the generations of employees. As the millennial generation (also commonly known as Gen-Y and includes births from 1982–2000) grows in the workforce and *baby boomers*\* retire, managers and human resources professionals will need to develop new engagement models that take into account the generational differences between baby boomers and millennials. In this article, I will highlight some of the characteristics that differentiate millennials from other generations and explain why employee engagement should be *top of mind* for managers.
- B** Baby boomers are currently the largest generation of active workers. Research has shown that boomers identify their strengths as organizational memory\*, optimism and their willingness to work long hours. This generation grew up working in organizations with large corporate hierarchies, rather than flat management structures and teamwork-based job roles.
- C** Millennials have a drastically different outlook on what they expect from their employment experience. Millennials are well educated, skilled in technology, very self-confident, able to multi-task and have plenty of energy. They have high expectations for themselves, and prefer to work in teams, rather than as individuals. Millennials seek challenges, yet work-life balance is of utmost importance to them. They do, however, realize that their need for social interaction, immediate results in their work and desire for speedy advancement may be seen as weaknesses by older colleagues.
- D** The millennial generation is the largest age group to emerge since the baby boom generation, and as this group grows into a significant proportion of the workforce over the next 20 years, employers will need to make major adjustments in their engagement models. Motivating, engaging and retaining people will never cease as managerial priorities, but employers will have to carefully consider what strategies they will use to cultivate and retain valuable millennial employees now and into the future.
- E** Millennials are creating a change in how work gets done, as they work more in teams and use more technology. Their social mindset, however, is also a significant factor. As Leigh Buchanon writes in *Meet the Millennials*, 'One of the characteristics of millennials, besides the fact that they are masters of digital communication, is that they are primed to do well by doing good. Almost 70 percent say that giving back and being civically engaged are their highest priorities.'

- F** Coupled with the socially minded millennial comes their desire to be creative. Millennials have grown up in a time where information has become available instantly. Through a Google or Wikipedia search, answers to even quite complicated questions can be found. As such, millennials have developed into a group that wants to work on new and tough problems, and ones that require creative solutions. In a 2009 article by Tamara Erickson, a millennial who had been struggling in her role, she admitted to peers that, 'I guess I just expected that I would get to act on more of my ideas, and that the higher-ups here would have figured out by now that the model's changing' (*Gen-Y in the Workforce*, Tamara Erickson, Harvard Business Review, February 2009).
- G** The millennial employee is interested in feedback on his or her performance. But traditional semi-annual reviews are too infrequent for millennials. They want to know that they've done a good job, and they want to know now. A 2008 article in *Nonprofit World* provides readers with a checklist on the topic of providing millennial feedback. The list includes: give them checklists, offer plenty of help, reward them for innovating and taking appropriate risks, engage them with frequent feedback, provide them with mentors, create a collegial and team-oriented culture, etc. Feedback must also be given in such a way that millennials are receptive.







The selection of indicators and parameters for a programme of water quality assessment and analysis is likely to be country- (and possibly region-) specific and may also be specific to certain sources of water. Furthermore, the range of analysis and frequency of testing will be constrained by the resources available for water quality sampling and analysis and, whilst it may be desirable that a great number of indicators and parameters are analysed frequently, budget constraints may restrict the frequency of sampling and testing, or the number of indicators/parameters to be analysed. In general, however, there are some basic rules that should guide the development of water quality assessment programmes.

The first step in deciding whether a particular indicator/parameter should be included in the assessment programme is to make a judgment on the following critical questions:

- Is the contaminant or substance known to be present or absent in the waters of the country?
- If known to be present or if no information is available, then the indicator/parameter should be included. If it is known to be absent, then it should be excluded.
- If known to be present, at what concentration does the contaminant exist and does the concentration approach or reach levels which are of public health concern?
- What is the extent (temporal and spatial) of the presence of the contaminants?
- Are there any current or planned activities in catchment areas that may cause the contaminant to be present in water or levels to increase?



## Reading Passage 3

You should spend 20 minutes on questions 1–12, which are based on Reading Passage 3.

### The Millennium Development Goals

The MDG drinking water target has been reached. Over 2 billion people gained access to improved water sources from 1990 to 2010, and the proportion of the global population still using unimproved sources is estimated at only 11 per cent. This is less than half of the 24 per cent estimated for 1990. Almost 6.1 billion people, 89 per cent of the world's population, were using an improved water source in 2010. The drinking water target has thus become one of the first MDG targets to be met.

While this tremendous achievement should be applauded, a great deal of work remains.

First, huge disparities exist. While coverage of improved water supply sources is 90 per cent or more in Latin America and the Caribbean, Northern Africa and large parts of Asia, it is only 61 per cent in sub-Saharan Africa. Coverage in the developing world overall stands at 86 per cent, but it is only 63 per cent in countries designated as 'least developed'. Similar disparities are found within countries – between the rich and poor and between those living in rural and urban areas.

Second, complete information about drinking water safety is not available for global monitoring. Systematically testing the microbial and chemical quality of water at the national level in all countries is prohibitively expensive and logistically complicated; therefore, a proxy indicator for water quality was agreed upon for MDG monitoring. This proxy measures the proportion of the population using 'improved' drinking water sources, defined as those that, by the nature of their construction, are protected from outside contamination. However, some of these sources may not be adequately maintained and therefore may not actually provide 'safe' drinking water. As a result, it is likely that the number of people using safe water supplies has been over-estimated.

Finally, more than 780 million people remain unserved. Although the MDG drinking water target has been met, it only calls for halving the proportion of people without safe drinking water. More than one tenth of the global population still relied on unimproved drinking water sources in 2010.

Assessing progress towards the MDG target alone creates an incomplete picture, since countries that started out with low baseline coverage have had to work much harder to halve the proportion of the population without water and sanitation. Added to this is the challenge of rapid population growth, which can easily mean that any gains in people served are overtaken by population growth. Moreover, it is the poorest countries that are often characterized by a combination of low baseline coverage and high population growth. This means that countries may be making significant progress in the absolute number of people served, but still be persistently 'off track'.

In response, the JMP\* has developed an alternative indicator that represents the proportion of the current population that has gained access over the period from 1995 to the most recent update, in this case 2010. It is thus the percentage of people living in a country today who have gained access in the last 15 years.

This indicator can be used to assess a country's performance irrespective of whether it started out with high or low baseline coverage. The indicator is expressed as: the increase since 1995 in the number of people with access as a proportion of the current (2010) population.

The graph shows selected countries in sub-Saharan Africa that have performed above the regional average of nearly 26 per cent. Some countries have made remarkable progress in providing large proportions of their population with access to improved drinking water sources, and this is true even of countries that are off track in terms of MDG progress. Rwanda and Sierra Leone, for instance, both experienced conflict during the period 1995 to 2010, but have nevertheless shown greater progress than that suggested by the regional average. In Rwanda, more than 30 per cent of the population have gained access to improved drinking water sources since 1995; this represents over 3 million people. Even countries that have not reported such good progress are noteworthy in terms of the number of people served.

The Democratic Republic of the Congo has provided improved water sources for only about 16 per cent of its population since 1995; still, this represents more than 10 million people. It is remarkable that sub-Saharan Africa has outstripped Eastern Asia in terms of the proportion of the current population that have gained access in the last 15 years.





**A** In 1961, when the Russian astronaut, Yuri Gagarin, piloted the first manned space flight, space travel was still no more than a fantasy. All the same, long before space flight became a reality, Jules Verne and H. G. Wells had proposed creative solutions to some of its more obvious challenges, such as defying the force of gravity. In Verne's 1865 science fiction novel, *From the Earth to the Moon*, a group of Americans invented a huge cannon from which they planned to fire three men up to the Moon. In his 1901 novel, *First Men in the Moon*, Wells described a spaceship made of an imaginary gravity-defying material that would float up to the moon with its passengers inside.

Interest in the phenomena of space is not recent, its origins being lost in the shadows of antiquity. Impelled by curiosity and a desire to understand, man has long studied, charted and debated the mysteries of the celestial spheres. Out of this interest eventually came the revolution in thought and outlook initiated by Copernicus, supported by the remarkably precise measurements of Tycho Brahe, illuminated by the observations of Galileo and the insights of Kepler, and given a theoretical basis by Newton in his proposed law of gravitation. The Copernican revolution continues to unfold today in human thought and lies at the heart of modern astronomy and cosmology.

Yet, until recently, outer space was inaccessible to man, and whatever was learnt about the sun, planets and stars was obtained by often elaborate deductions from observations of the radiations that reached the surface of the Earth. Nor were all the inaccessible reaches of space far away. The ionosphere, important because of its role in radio communications, was not as far away from the man on the ground below as Baltimore is from Washington. Nevertheless, until the advent of the large rocket, the ionosphere remained inaccessible not only to man himself but even to his instruments. As a result many of the conclusions about the upper atmosphere and the space environment of the Earth were quite tentative, being based on highly indirect evidence and long chains of theoretical reasoning. Time and again the theorist found himself struggling with a plethora of possibilities that could be reduced in number only if it were possible to make in situ measurements. Lacking the measurements, the researcher was forced into guesswork and speculation.

Small wonder, then, that when large rockets appeared they were soon put to work carrying scientific instruments into the upper atmosphere for making the long-needed in situ measurements. From the very start it was clear that the large rocket brought with it numerous possibilities for aiding the investigation and exploration of the atmosphere and space. It could be instrumented to make measurements at high altitude and fired along a vertical or nearly vertical trajectory for the purpose, falling back to Earth after reaching a peak altitude. When so used the rocket became known as a sounding rocket or rocket sonde, and the operation was referred to as sounding the upper atmosphere.

A rocket could also be used to place an instrumented capsule into orbit around the Earth, where the instruments could make extended-duration measurements of the outer reaches of the Earth's atmosphere or observations of the sun and other celestial objects. Or the rocket might launch an instrumented capsule on a trajectory that would take it far from the Earth into what was referred to as deep space, perhaps to visit and make observations of the moon or another planet. The orbiting capsules were called artificial satellites of the Earth; those sent farther out came to be known as space probes or deep space probes. Finally, the ultimate possibility of carrying men away from the Earth to travel through deep space and someday to visit other planets emphasized dramatically the new power that men had acquired in the creation of the large rocket.

A language of rocketry emerged, which the news media popularized. Familiar words took on new meanings, and new terms were encountered: artificial satellite, spacecraft, space launch vehicle, rocket stages, countdown, lift-off, trajectory, orbit, tracking, telemetering, guidance and control, retrorockets, re-entry and space science.

Through all the centuries of scientific interest in space phenomena, the phrase space science had not gained common use. That the terminology did not come into use until after rockets and satellites brought it forth gives force to the definition of space science given at the start of this section. That definition sets forth the meaning in mind when in June 1957 the US National Academy of Sciences combined the functions of the IGY Technical Panel on Rocketry and the IGY Technical Panel on the Earth Satellite Program into a single board, naming it the Space Science Board.

### People who are alive today will walk on Mars

- A** Charles Bolden, NASA's administrator, averred that the robotic vehicle *Curiosity* will 'blaze a trail for human footprints on Mars'. He could be right. But there is a gulf between what is technically feasible and what is actually achieved.

- E** The main impediment to a manned NASA programme has always been that public and political opinion constrains it into being too risk-averse. The space shuttle failed twice in 135 launches. Although astronauts or test pilots would willingly accept this risk level, the shuttle had been promoted as safe for civilians. So each failure caused a national trauma and was followed by a hiatus in the programme while costly efforts were made – with very limited effect – to reduce the risk still further.
- F** Unless motivated by pure prestige, ambitious manned missions will be viable only if they are cut-price ventures, accepting high risks – perhaps even 'one-way tickets'. These may have to be privately funded; no Western government agency would expose civilians to such hazards.
- G** The SpaceX company, led by the entrepreneur Elon Musk, has successfully sent a payload\* into orbit and docked with the Space Station. The involvement in space projects of Mr Musk and others in the high-tech community with credibility and resources is surely a positive step.
- H** Richard Branson will soon be lobbing people into space to experience a few minutes of weightlessness. Within a few years private companies will offer orbital flights. Maybe after another decade the really wealthy will be able to take a week-long trip around the far side of the Moon – voyaging farther from Earth than anyone has been before but avoiding the greater risks of a Moon landing and blast-off.
- I** The phrase 'space tourism' should, however, be avoided. It lulls people into believing that such ventures are routine and low-risk. If that becomes the perception, the inevitable accidents will be as traumatic as those of the space shuttle. Remember that nowhere in our solar system offers an environment as clement even as the Antarctic or the top of Everest. It is foolish to claim, as some do, that mass emigration into space offers escape from Earth's problems.

**J** But I believe, and hope, that some people living now will walk on Mars. Moreover, a century or two from now, small groups of intrepid adventurers may be living there or perhaps on asteroids quite independently from Earth. Whatever ethical constraints we impose here on the ground, we should surely wish such pioneers good luck in genetically modifying their progeny to adapt to alien environments.

**K** This might be the first step towards divergence into a new species: the beginning of the post-human era. And machines of human intelligence could spread still farther. Whether the long-range future lies with organic post-humans or intelligent machines is a matter for debate. Either way, dramatic cultural and technological evolution will continue not only here on Earth but far beyond.



That is, Super Bowl viewers tend to turn off their laptops, cell phones, digital recorders, etc. specifically to 'watch' not only the game, but also the new commercials that they will then talk about afterwards (Gunter and Furnham, 1997; Jensen, 1998; Mohr, 2007; Poole, 2007).
- B** More recently, the attractiveness of running ads during the Super Bowl has been found in cyberspace too. According to a Google executive, about 90% of brands advertising on TV during the 2009 Super Bowl also had ads up on YouTube. A quarter also tapped social networks to try and drive up additional comments, ratings and conversation (Klaassen, 2009). There is a trend for Super Bowl ads to draw significant amounts of online traffic to advertisers' branded websites. Anheuser-Busch found that traffic to its branded websites rose by 600 per cent, or 21 million views, in the seven days following its Super Bowl ads in 2008 (Mullman, Steinberg, Halliday, Zmuda and Parekh, 2009). For these reasons, obtaining spots during the Super Bowl telecast has become a competition in and of itself. In 2009, companies were willing to invest \$3 million for a 30-second commercial spot (Futterman and Vranica, 2008).
- C** Although the Super Bowl serves as an advertising vehicle for many companies, very little is known about the creative strategies these companies employ to promote their products and services in Super Bowl commercials. This is rather surprising, given that Super Bowl advertising is considered cutting-edge from a creative perspective. For example, Apple Computer's '1984' ad, which introduced the Macintosh personal computer in a George Orwell-style, is considered one of the greatest commercials of all time in the US (Horton, 1990). Nonetheless, only a few studies have examined the creative strategies of Super Bowl commercials.

Branding, which has become a highly successful income stream in the last few decades, is an example of this. For example, a T-shirt or a mug branded with the logo of a European premier league football club may be produced on a continent as far away as Asia. A further, and even more productive, source of income is the sale of broadcasting rights. For example, in 2010, the governing body of world football (FIFA), earned 2408 million US dollars from the sale of the television rights to the FIFA World Cup™ in South Africa and 1072 million US dollars in marketing rights. Another profitable, but arguably dubious, commercial operation is the transfer of players from one football club to another. Although individual players receive astronomical fees as a result of these transfers, it is difficult to view the process as being very different from that of trading manufactured goods.

- E** As well as raising specific ethical issues, the transfer of players for large sums of money highlights the tension between the social ideals on which many sporting associations are founded and commercial necessity. Although many sports clubs may still retain their original social aims, such as health, social interaction and physical development, the financial pressures of the modern competitive world of international business prevent them from attaining these aspirations.
- F** These concerns were echoed some years ago by Bayle and Durand (in Rouvrais-Charron and Durand, 2009) who noted 'a growing gap between ethics and behaviour' amongst the governing bodies of international sport. It must be recognized that the challenge of balancing ideology, social responsibility and commercial viability is not unique to football. Nevertheless, it could be argued that if sport (and in this case, football) is based on the principle that it has a uniquely social function, this conflict between ideology and commercial pressure may be felt to be all the more acute.



It is widely documented that immigrant parents, who are typically members of minority groups, may experience stress, alienation, discrimination or inherent gaps with the majority group and find themselves raising children in the context of more than one language. Parents in these groups often attribute their decision or efforts to encourage L2\* acquisition for themselves as well as for their children (parallel to L1\* maintenance) to the potential economic benefits of bilingualism (e.g., Curdt-Christiansen, 2009; Guardado, 2008; King and Fogle, 2006), emphasizing the advantages of being absorbed into the wider society and the necessity of mastering the majority language for the sake of better work prospects in the future. This pattern can serve as an example of a coping mechanism. It is an explicit opinion frequently leading to an explicit decision, which protects family members (mainly the parents) from psychological disequilibrium. They consciously and purposefully decide to promote bilingualism in the family, pointing to its benefits and strengthening themselves as a system.

Another common finding when exploring FLP\* is the insistence on language maintenance so as to facilitate the children's communication with members of the extended family, to promote family cohesion and to enable free and spontaneous communication between parents and children (e.g., Pavlenko, 2004; Smolicz et al, 2001; Tannenbaum, 2005; Tannenbaum and Howie, 2002). This too is an instance of a coping mechanism, since it involves explicit, conscious ideas about language and family dynamics to increase adaptiveness. It could also, however, be a defensive one. Many immigrants are not aware that, by promoting language maintenance, they are applying defensive strategies that often serve to protect the integrity of the family system ... These strategies involve, *inter alia*, maintaining strong emotional contact with the past, with childhood memories, parents and grandparents via language maintenance; or witnessing children developing competency in the parental language, which in turn may lead to further identification with the children, and/or prevent alienation and remoteness when children develop mastery only in L2; or maintaining symbolic links with the parental heritage.

### Parental roles

One of the most enduring elements of social and behavioural science research in the last half of the 20th century was the scholarly re-examination of traditional ideas about fatherhood and motherhood. For over 200 years maternal behaviour had been considered paramount in child development (Kagan, 1978; Stearns, 1991; Stendler, 1950; Sunley, 1955), and fathers were often thought to be peripheral to the job of parenting because children throughout the world spent most of their time with their mothers (Fagot, 1995; Harris, Furstenberg and Marmer, 1998; Munroe and Munroe, 1994). Some argued that fathers contributed little to children's development except for their economic contributions (Amato, 1998), and others believed that fathers are not genetically endowed for parenting (Belsky, 1998; Benson, 1968). Indeed, even though Margaret Mead concluded that fathers were important contributors to childcare, and that '(a)nthropological evidence gives no support ... to the value of such an accentuation of the tie between mother and child' (Mead, 1956, pp.642–643), Mead (1949) perceived basic differences between fathers and mothers. The mother's nurturing tie to her child is apparently so deeply rooted in the actual biological conditions of conception and gestation, birth and suckling, that only fairly complicated social arrangements can break it down entirely ... But the evidence suggests that we should phrase the matter differently for men and women – that men have to learn to want to provide for others, and this behaviour, being learnt, is fragile and can disappear rather easily under social conditions that no longer teach it effectively (pp.191–193).

However, many contemporary scholars now cite a growing body of empirical evidence that parental behaviours are not simply the consequence of biology and human nature, but rather are informed by cultural, historical and social values, circumstances and processes. In fact, as gender ideologies shifted in the last half of the 20th century, so too did researchers' exploration of variations in men's and women's behaviour generally, and fathering and mothering specifically (Rohner and Veneziano, 2001; Sanchez and Thomson, 1997). Moreover, contemporary perspectives on fatherhood and motherhood are in large part derived from research that concurrently studied fathers and mothers, rather than earlier research that focused almost exclusively on mothers.

### Similarities and differences in fathers' and mothers' interactions with offspring

Much of the research into parent-child relations has been informed by the belief that mothers influence children's physical, emotional, psychological and social well-being through expressive and affective behaviours, including warmth and nurturance (Bowlby, 1969; Hojat, 1999; Mahler and Furer, 1968; Phares, 1992; Stern, 1995), whereas fathers have often been viewed as influencing children's development through the instrumental roles of provider and protector, and as role models for social, cognitive, psychological and gender-identity development (Bronstein, 1988; Gilmore, 1990; Lamb and Oppenheim, 1989; Mackey, 1996; Parsons and Bales, 1955; Radin, 1981b). However, contemporary research suggests that maternal behaviour is not situated exclusively in the expressive sphere any more than paternal behaviour is situated exclusively in the instrumental one. Indeed, multivariate research in the 1990s demonstrated the importance of paternal expressive and affective behaviours despite the fact that mothers are often characterized as 'superior caregivers', whereas fathers are

viewed as 'less capable of, and/or less interested in, nurturant parenting' (*Parents' Interactions with Offspring*, Hosley and Montemayor, 1997, p.175). As discussed below, fathers' and mothers' behaviours are in fact multidimensional and multifaceted, and these behaviours often vary as a result of contextual variables including youths' age and gender.

### Youths' age and gender

According to Collins and Russell (1991), research in Western societies shows that fathers and mothers interact differently with their middle childhood (i.e., preteens) to adolescent children than with younger children. For example, fathers generally interact with their adolescents through focusing on instrumental goals (e.g., school and athletic achievement, future plans) and objective issues such as political discussions. Mothers' interactions with adolescents, on the other hand, tend to be marked more by discussions of personal issues. More specifically, in their review of the literature on US families, Collins and Russell (1991) reported that 15- to 16-year-old US adolescents spent twice as much time alone with their mothers as with their fathers. Collins and Russell also reported that 14- to 18-year-olds, more than 12- to 13-year-olds, spent more time alone with their mothers than with their fathers. As for middle childhood, Collins and Russell (1991) found that mothers tend to be more involved in caregiving, whereas fathers are more involved in play activities.





A recent survey into the use of social networking websites has found that a large majority (80%) of adult members use the sites to chat online to friends or family they see a lot. A slightly lower percentage (76%) talk to members of the family they rarely see. Looking for old friends is only 1% less popular than looking at other people's pages (45%). The same percentage of users of social networking sites (25%) 'like' products and services and invite people to social events, while 23% of users go online to find out about events in the neighbourhood. 21% of online users log on to social networking sites to find out about bands and to read the sporting news. #### Could Facebook help predict obesity hotspots? Areas where people who 'like' TV more than sport are less healthy

- People with television-related Facebook 'interests' are more likely to be obese.
- Those related to a healthy lifestyle are less likely to have weight issues.
- People's online 'interests' could help predict and map obesity rates by area.

Facebook could be a key tool in mapping which geographical areas have the most overweight and obese people. American researchers have found that the higher the percentage of people in a city or town with Facebook 'interests' suggesting a healthy lifestyle, the lower that area's obesity rate. At the same time, areas with a large percentage of Facebook users with television-related 'interests' tend to have higher rates of obesity.

Researchers at Boston Children's Hospital, in the US, drew these conclusions after comparing Facebook user data with data from national and New York City-focused health surveys. They looked at what Facebook users posted to their timeline, 'liked' and shared with others. They then compared the percentage of users interested in healthy activities or television with details of Body Mass Index in the same area. The comparison revealed close geographic relationships between Facebook 'interests' and obesity rates.

For instance, the obesity rate was 12 per cent lower in the location in the United States where the highest percentage of Facebook users expressed activity-related 'interests', compared with that in the location with the lowest percentage.

Similarly, the obesity rate in the location with the highest percentage of users with television-related interests nationally was 3.9 per cent higher than the location with the lowest percentage.

The same correlation was reflected in the New York City neighbourhood data as well, showing that the approach can scale from national to local-level data.

The obesity rate on Coney Island, which had the highest percentage of activity-related 'interests' in the city, was 7.2 per cent lower than Southwest Queens, the neighbourhood with the lowest percentage. At the same time, the obesity rate in Northeast Bronx, the neighbourhood with the highest percentage of television-related 'interests', was 27.5 per cent higher than that in the neighbourhood with the lowest percentage – Greenpoint.

They now believe that people's online 'interests' could help public health researchers predict, track and map obesity rates by area. The amount of data available from social networks like Facebook makes it possible to efficiently carry out research with cohorts of a size that was previously impossible. Dr John Brownstein, from Boston Children's Hospital, explained: 'Online social networks like Facebook represent a new high-value, low-cost data stream for looking at health at a population level. 'The tight correlation between Facebook users' "interests" and obesity data suggest that this kind of social network analysis could help generate real-time estimates of obesity levels in an area, help target public health campaigns that would promote healthy behaviour change, and assess the success of those campaigns.'

### Their social life online: a parents' guide

Rachel Carlyle

Worried parents take heart – a growing body of research shows that teens who use social media are not reclusive geeks: they actually have a wider circle of real-life friends, a better sense of identity and belonging and are developing the essential technical skills they need to be citizens of a digital age.

'Social networking has become an embedded part of modern childhood,' says e-safety pioneer Stephen Carrick-Davies, who advises parents and schools on technology.

'Children do not consume media – dipping in and out to buy airline tickets or check emails as adults do – they inhabit it. That's neither good nor bad – it's what you do with it that counts.'

What teenagers mainly do with it is socialize with friends they already know. 'It's the modern equivalent of hanging around at the bus stop to share the in-jokes and catch up on the gossip: a kind of virtual bus stop,' says Tim Mungeam, a parenting consultant who runs social networking seminars for teens and their parents.

And it performs a similar function: helping teenagers develop a sense of identity away from their parents and learning to get on with their peers. Professor Kevin Durkin, a psychologist at Strathclyde University, says: 'Adolescence is a time when you are asking, who am I? Who do I want to become? Social networking can help you develop that self-identity: you can post notices about your favourite music or sports, discover what you enjoy, and you are constantly reminded that other people have different ways of looking at things and have different tastes. Research actually shows that keen social networkers are not as self-absorbed as others who don't.'

He says that embracing social media can also help shy teens blossom: 'They tend to find computer-mediated communication more comfortable than face-to-face, and there may be benefits from practising social skills in a less-threatening environment.'

Professor Andy Phippen, of Plymouth University, who is researching the use of social networking sites by teenagers, feels that these sites can also boost the confidence of children traditionally on the edge of friendship groups. 'Unlike in our day, when there were the Alpha\* kids and those very much on the periphery of friendship groups, social networking can bring in the ones on the periphery so there's not so much difference between them,' he says.

It can be a life-saver for the quiet, geeky child who has a specialized interest because it can allow them to connect with others with similar interests. 'If you are one of only three kids in your school in Cornwall who is into Emo\* culture, traditionally you would have felt quite isolated. But if you discover a social networking group of like-minded teenagers, there's suddenly a necessary critical mass and you can still be popular, just in a different context,' Professor Phippen adds.

Experts always used to advise monitoring your children's social networking activities, but there is a growing consensus that once they reach 13 or 14, and parents are happy they know the ground rules (stay civil, be kind, don't give out personal details to those you don't know in real life) they should trust them to get on with it.

It's the teenagers who are able to find new interests online, join networks of likeminded individuals – and then create their own content – who are really harnessing the potential of social networks, says Pamela Whitby, the digital education expert and author of *Is Your Child Safe Online?*

'Social networking is becoming a creative force: teenagers are making videos, joining YouTube groups, podcasting and blogging about the things that interest them. Sites like Pinterest, which is like a digital look-book, and Instagram, a photosharing network, are transforming creativity, and I think niche networks are going to become more and more common.

'I recently went into a school and thought I would be telling all these teenagers about how to use Instagram – but many were already using it. The keen photographers were networking with each other, learning skills, swapping images and deepening their own interest. This all adds to their employability and will undoubtedly benefit them in the workplace.

'Every single business is using social media to sell and to increase brand-awareness – and you need to understand how it works and how it can create customers. For example, if you develop a product and you have 700 friends on Facebook and 300 on other networks, they are all potential customers for that product. If you link all those networks together there's your customer base right there.'

Teenagers who use social networking as a creative force will reap the benefits in the world of work, agrees Mungeam. 'One of the fantastic aspects of Facebook and YouTube is the opportunity for collaborating with others to create content, then sharing it with others. Collaboration is a real 21st-century skill, and an essential part of being employable in a digital age.

'Social networking helps them find out what they are passionate about. They can be in touch with people all over the world sharing ideas and gradually they can build their online reputation: signing up to campaigns or joining groups to make their voice heard.

'Social networks amplify one person's voice, and no one appreciates this more than a teenager.'

Teenagers who use social networks will reap the benefits in the world of work.



#### Number working beyond State Pension Age doubles over past two decades

The number of older workers, defined here as those working beyond State Pension Age (SPA), has almost doubled from 753 thousand in 1993 to 1.4 million in 2011. Over the period, the number remained relatively flat between 1993 and 2000 but quickly rose to a peak of 1.45 million in 2010.

Over the period, with an ageing population and with the post-World War II 'baby boom' generation reaching SPA, the population of older people has increased. Likewise, looking at the percentage of the older population in employment this too has increased from 7.6 per cent in 1993 to 12 per cent in 2011. This shows that the number of workers above SPA has risen at a faster rate than the population.

There may be many factors influencing the decision for more people to work past SPA, such as the improved health and well-being of this group, financial pressures, people living longer and wanting to remain active in society, and others.

Now focusing on the final quarter of 2011, workers over SPA were more likely to be self-employed than their younger counterparts (those aged between 16 up to SPA). Around 32 per cent of workers above SPA were self-employed compared to just 13 per cent of those below SPA.

Also, workers over SPA were twice as likely to be working part-time (66 per cent) than full-time (34 per cent). For those under SPA, three-quarters (75 per cent) worked full-time and the remaining 25 per cent worked part-time.

This shows that when working over the State Pension Age, those remaining in the labour market work fewer hours, possibly helped by the financial support of their state pension and other pension arrangements, which allows them to fit their work around other engagements.

### How can retirement affect health?

This analysis raises an important question: is the decreased labour force participation rate partly responsible for the improvements in general health? This question is important. If a longer working life induces health deterioration, then a policy of trying to encourage people to work longer will be much less attractive. Furthermore, since healthcare is mostly publicly funded in the UK, a decline in health as a result of policies that induce longer working lives may lead to increases in health spending. At the same time, of course, such policies would also produce more suffering among the elderly, who would pay for their labour force participation with poorer health.

On the other hand, it is also possible that retirement may be to the detriment of health, so policies to induce longer working lives could, in fact, produce even better improvements in life expectancy and healthy life expectancy. In fact, Milligan and Wise (2012) find little relationship between mortality and employment rates at the country level. For any given mortality rate, the employment rate among older men varies significantly across countries, and changes in mortality within countries are weak predictors of changes in employment rates of older men. However, mortality is a rather crude measure of health. Secondly, it is not necessarily the case that the apparently non-existent relationship between employment and health holds up in microlevel analyses. Indeed, the evidence clearly suggests deteriorations in health-induced retirement at the individual level in the British context (Disney et al, 2006).

Theoretically, the impact of retirement on health is far from certain. According to the human capital model of Grossman (2000), good health is crucial for allowing individuals to maximize their utility. Health has an impact on utility directly through its effect on people's life satisfaction and happiness while also reducing work-related illness which, in turn, allows people to raise their total earnings. The former mechanism may lead people to invest more in their health after retirement – since they have more time to enjoy their leisure activities – whereas the latter mechanism may lead them to invest less, since they no longer have a job with which to increase their earnings. Whether incentives to invest in health increase or decrease after retirement depends on whether the marginal benefit of better health is higher or lower compared with before retirement, and there is no straightforward correct answer regarding which scenario is correct (Dave et al, 2006). Additionally, it is important to note that health investments may change prior to retirement, since individuals engage in retirement planning, the effects of which may kick in once they have retired. Also it should be noted that investment in health may not be primarily monetary investments. They can include making changes to diet, developing a daily exercise routine, and so on.

Other mechanisms by which retirement can affect health appear equally ambiguous. The social capital literature\*, for example, indicates beneficial effects of trust and social interactions on health (for example, see Petrou and Kupek, 2008; d'Hombres et al, 2010, Ronconi et al, 2012). It is plausible that retirement can reduce social networks if these mostly stemmed from a person's job. However, the retired also have more leisure time, which can be used to establish new social contacts outside work. Additionally, retired people have more time to devote to voluntary work, which is also a base from which new contacts can be established.

Equally, while stress is clearly detrimental to health, the impact of retirement on stress is also not clear-cut. Retirement is an important life event that can be very stressful, but it can also decrease work-related pressure. The same applies for physical exercise. Some people get most of their exercise from work, whereas retirement may allow others to exercise more on a voluntary basis. Indeed, the impact of retirement on exercise appears to vary depending on the type of people and the type of job from which they exit (Chung et al, 2009; Kuvaja-Köllner et al, 2012).

Another mechanism by which retirement affects health is through what is termed the 'income effect'. When people retire, they are likely to see a drop in their income. This, in turn, might affect their health negatively.

Furthermore, it is important to note that the health impact of retirement is not necessarily linear: immediate and short-term effects may differ significantly from medium- and long-term impacts. The mechanisms linking retirement to health can involve very long delays. It is clearly plausible that the longer-term health effects of retirement can differ significantly from the short-term impact. For example, the reduction in stress may have a beneficial short-term impact but the reduced social contact may have a detrimental longer-term impact.

## Sea level rising

Global average sea level has increased over 8 inches since 1880, and global warming has caused the great majority, if not all, of that rise. Warming has acted in two main ways: by heating up and thus expanding the global ocean; and by attacking glaciers and polar ice sheets, pouring meltwater and icebergs into the sea. The planet has heated by more than one degree Fahrenheit over the last century, rising faster as we have burnt coal, oil and gas faster, and so sent ever more heat-trapping gases into the air. Scientists overwhelmingly agree that these building gases are responsible for most of the warming observed thus far.

Warming and sea-level rise are both accelerating, as is the rate of decay of ice sheets on Greenland and Antarctica. Loss of ice from these sources has the potential to raise sea level by many tens of feet over centuries. In the warm period before the last Ice Age – when the planet was as warm as we expect it to become by 2100 or sooner, at least without deep and immediate cuts to pollution – global sea level very likely reached over 20 feet higher than it is today, an eventual sea level we could be committing to within decades if not already. That rise would be enough to drown many major coastal metropolises.

This century, scientists expect about 20 to 80 more inches of global sea-level rise, depending significantly on how much more heat-trapping pollution humankind puts into the sky. The amount also depends on just how strongly pollution translates into warming, and just how strongly warming translates into sea rise.


#### Rising sea levels threaten coastal cities

Since 1880, sea levels have risen an average of 8 inches globally. Calculations vary, but there is common consensus that, as a result of global warming, oceans will heat up and expand at an increasing pace and sea levels will consequently rise more rapidly. Some scientists calculate that the sea will rise between 6 and 15 inches by 2050 and between 12 and 48 inches by 2100. Experts predict that if this trend continues, many coastal settlements will be susceptible to flooding within the next century, and that some will be in danger of disappearing altogether.

Unusually high tides and storm surges in recent years, have already caused serious flooding in cities worldwide, including New York, New Orleans and Venice. Although, this in itself does not pose an immediate threat to their survival, there is evidence that rising sea levels could lead to the inundation of major cities by the end of the 21<sup>st</sup> century.

If scientific calculations are accurate, Venice would be completely submerged if sea levels rose by 42 inches. The Hague in Holland, another low-lying European city, would also be affected by rising sea levels. Like Venice, it is only 39 inches above today's sea level, and would be totally submerged if sea levels rose by 45 inches. On the other hand, central New York, at an elevation of 79 inches above sea level, would not be submerged until the level of the ocean rose by 80 inches, while the greater part of San Francisco would disappear under the sea with a rise in sea level of only 42 inches.

#### Traditional knowledge and past experience

Adaptive capacity and resilience can also be strengthened through the application of traditional knowledge and past experience of environmental changes. In the TAR\*, Nurse et al (2001) noted that some traditional island assets, including subsistence and traditional technologies, skills and knowledge, and community structures, and coastal areas containing spiritual, cultural and heritage sites, appeared to be at risk from climate change, and particularly sea-level rise. They argued that some of these values and traditions are compatible with modern conservation and environmental practices.

Since then, several examples of such practices have been described. For instance, Hoffmann (2002) has shown that the implementation of traditional marine social institutions, as exemplified in the Ra'ui in Rarotonga, Cook Islands, is an effective conservation management tool, and is improving coral reef health; while Aswani and Hamilton (2004) show how indigenous\* ecological knowledge and customary sea tenure\* may be integrated with modern marine and social science to conserve the bumphead parrotfish in Roviana Lagoon, Solomon Islands. Changes in sea tenure, back to more traditional roles, have also occurred in Kiribati (Thomas, 2001).

The utility of traditional knowledge and practices can also be expanded to link not only with biodiversity\* conservation but also with tourism. For instance, in a coastal village on Vanua Levu, Fiji, the philosophy of *vanua* (which refers to the connection of people with the land through their ancestors and guardian spirits) has served as a guiding principle for the villagers in the management and sustainable use of the rainforest, mangrove forest, coral reefs and village gardens. Sinha and Bushell (2002) have shown that the same traditional concept can be the basis for biodiversity conservation, because the ecological systems upon which the villagers depend for subsistence are the very same resources that support tourism. These examples indicate that local knowledge, management frameworks and skills could be important components of adaptive capacity in those small islands that still have some traditional foundations.

## Reading Passage 9

You should spend 20 minutes on questions 1–13, which are based on Reading Passage 9.

The Antarctic Peninsula is a rugged mountain chain generally more than 2000 metres high, differing from most of Antarctica by having a summer melting season. Summer melt produces many isolated snow-free areas, which are habitats for simple biological communities of primitive plants, microbes and invertebrates\*, and breeding grounds for marine mammals and birds. The Antarctic Peninsula has experienced dramatic warming at rates several times the global mean (Vaughan et al, 2003; Trenberth et al, 2007). Since the TAR\*, substantial progress has been made in understanding the causes and profound impacts of this warming.

Since records began, 50 years ago, mean annual temperatures on the Antarctic Peninsula have risen rapidly:  $>2.5^{\circ}\text{C}$  at Vernadsky (formerly Faraday) Station (Turner et al, 2005). On the west coast, warming has been much slower in summer and spring than in winter or autumn, but has been sufficient to raise the number of positive-degree days by 74% (Vaughan et al, 2003), and the resulting increase in melt has caused dramatic impacts on the Antarctic Peninsula environment, and its ecology.

Around 14 000  $\text{km}^2$  of ice have been lost from 10 floating ice shelves (King, 2003), 87% of glacier termini\* have retreated (Cook et al, 2005), and seasonal snow cover has decreased (Fox and Cooper, 1998). The loss of seasonal snow and floating ice do not have a direct impact on global sea level, but acceleration of inland glaciers due to the loss of ice shelves (De Angelis and Skvarca, 2003; Scambos et al, 2004; Rignot et al, 2005) and increased run-off of melt water (Vaughan, 2006) will cause an increase in this contribution. If summer warming continues, these effects will grow.

Marine sediment\* cores show that ice shelves probably have not reached a similar minimum for at least 10 000 years (Domack et al, 2005), and certainly not for 1000 years (Pudsey and Evans, 2001; Domack et al, 2003). This suggests that the retreat is not simply due to cyclic variations in local climate, and that recent warming is unique in the past 10 000 years (Turner et al, 2007). The processes leading to warming are unclear, but appear to be correlated with atmospheric circulation (van den Broeke and van Lipzig, 2003) and particularly with changes in the Southern Annular Mode\* caused by anthropogenic\* influence (Marshall et al, 2004; Marshall et al, 2006). The winter warming on the west coast also appears to be related to persistent retreat of sea ice (Parkinson, 2002) and warming in the Bellingshausen Sea (Meredith and King, 2005). The spring depletion of ozone over Antarctica (the Antarctic Ozone Hole) has also been implicated in driving circulation change (Thompson and Solomon, 2002), but this has been disputed (Marshall et al, 2004). Current general circulation models (GCMs) do not, however, simulate this observed warming over the past 50 years (King, 2003) and we cannot predict with confidence whether rapid warming will continue in the future.


If warming does continue (especially in the summer) there will be significant impacts; retreat of coastal ice and loss of snow cover would result in newly exposed rock and permafrost\* – providing new habitats for colonization by expanding and invading flora and fauna. However, the direct impacts of climate change on the flora and fauna are difficult to predict, since these ecosystems are subject to multiple stressors. For example, increased damage by ultraviolet exposure, because of reduced ozone levels and summer desiccation\*, may oppose the direct responses to warming (Convey et al, 2002). In addition, there is a growing threat of alien species

invasion, as climatic barriers to their establishment are eroded by climate amelioration\*, and increasing human activity increases the opportunity for introduction. Such invasions have already occurred on many sub-Antarctic islands, with detrimental consequences for native species (Frenot et al, 2005). Furthermore, slow reproduction rates during rapid climate change may limit the possible relocation of native species.



#### Facilitating lifelong participation in sport and physical activity

**A** According to the UK's Department of Education and Science (1992) the purpose of learning in physical education (PE) is to develop specific knowledge, skills and understanding, and to promote the physical development and competence that determines long-term engagement in sport and physical activity. Other countries make similar statements in policy documentation (see, for example, the contributors in Pühse and Gerber, 2005). In fact, in their survey of 52 countries around the world, Bailey and Dismore (2006) found that the promotion of lifelong physical activity was a universal aim of PE. Such expectations are not without justification, as a large body of literature suggests that PE – as the main societal structure for the promotion of regular physical activity during childhood – is the most suitable vehicle for promoting lifelong participation in sport and physical activity (Fairclough, Stratton and Baldwin, 2002; McKenzie, 2001; Shephard and Trudeau, 2002; Trudeau, Laurencelle and Shephard, 2004).

**B** In most developed countries children experience some form of regular curricular PE between the ages of 5 and 16 years (Hardman, 2001; Hardman and Marshall, 2009; Pühse and Gerber, 2005). However, many children do not maintain a lifelong involvement in sport or physical activity (Green, 2002; Roberts, 1996; Sallis and McKenzie, 1991). We suggest that this is, at least partly, ascribable to the poor quality of the PE experience. Ten years ago, Williams (2000) described primary PE in England as mixed in quality. After an investment of approximately £1 billion in PE and school sport, one government adviser was only able to say that 'a few schools are beginning to explore how they can realistically expect higher levels of achievement from a greater proportion of pupils, but this culture is proving slow to change' (Casbon, 2006, 15). This does not seem to be a local problem, as a number of international surveys have described similar situations elsewhere. Hardman and Marshall's (2009) worldwide survey, for example, revealed considerable cause for concern in terms of contributory factors for quality provision

in both developing and developed countries. As a consequence, the foundation provided is so inconsistent that the start of the pathway is undermined. At the secondary level, PE is largely organized into short blocks of physical activities dominated by team sports that may not necessarily equip learners with the skills needed for lifelong participation in sport and physical activity (Fairclough, Stratton and Baldwin, 2002; Kirk, 2010; Penney and Jess, 2004; Trost, 2006). In fact, research in PE is increasingly concerned that the movement skills, knowledge and understanding essential for lifelong participation are not 'integral, explicit and valued elements of physical education' (Penney and Jess, 2004, 275). Roberts (1996) noted that PE teachers defend a 'sport for all' approach to curricular PE on the premise that by including a range of sports and activities more 'pupils would be able to find a sport at which they were competent and which they enjoyed and this would extend their participation into out-of-school and post-school lives' (1996, 50). Kirk's (2010) analysis suggests that a multi-sport approach continues to dominate and shows little sign of losing influence. However, Penney and Jess (2004) argue that it is important to broaden the skills, knowledge and understanding encompassed in PE curricula that claim to facilitate lifelong engagement in sport and physical activity.

Food choices are driven primarily by a child's familiarity with food and secondly by taste. Perceptions of which foods should be eaten in moderation and an understanding of balancing a diet appear to be weak. Where there is a wide variety of choice, children naturally choose the foods they like the most and even if more healthy foods are offered, a balanced meal may not always be chosen. Children and young people tend to leave the healthier elements of a meal while eating the less healthy items. Foods high in sugar and low in fibre, iron and vitamin A are frequently chosen and children's understandings of the dangers of a high-salt diet are also generally poor. Scottish children, and especially boys, have the highest likelihood of having a diet furthest from healthy-eating guidelines and minority groups, particularly South-Asian populations, have shown to be lacking in vitamin D and tend to eat more unhealthy foods and fewer vegetables than white Europeans.

Overall, children's knowledge of the positive benefits of fruit is greater than their knowledge of vegetables, and children tend to prefer fruit to vegetables. It is also easier to increase a child's consumption of fruit than it is vegetables. Apples and oranges are generally the most popular fruits although preference for both fruit and vegetables has been shown to vary with age and sex, with fruit intakes being higher among teenage girls than teenage boys and higher in England than in Scotland. Children participating in school fruit and vegetable schemes tend to have greater nutritional knowledge about fruit and vegetables than those not participating in schemes. Such schemes may be associated with a lower intake of fruit and vegetables in the home if parents rely on schools to provide children with their daily portions. Although schemes can increase fruit and vegetable intake in the short term, this increase tends not to be maintained once the intervention is withdrawn.

## Reading Passage 10

### Malnutrition and children's learning

- A** The impact of malnutrition on children's learning is not simply that they are tired and unable to concentrate in class because they have not eaten enough on a given day. Malnutrition in the first 1000 days – from the start of a woman's pregnancy until her child's second birthday – has a devastating impact on children's future potential. It restricts their cognitive development, means they are more likely to be sick and miss out on school, and reduces their ability to learn.
- B** This 1000-day window is a critical time for structural brain development. Good maternal nutrition is essential: pregnant or breastfeeding mothers who can't access the right nutrients are more likely to have children with compromised brain development and who suffer from poor cognitive performance. And once the child is born, nutrition continues to play a key role in ensuring the brain develops properly. But the effects of malnutrition on a child's cognitive development and education go beyond the biology of the brain. A child's nutritional status can impact on the experiences and stimulation that children receive. Parents sometimes treat a malnourished boy or girl differently because they are small, and this child is also more likely to miss school and key learning opportunities due to illness.
- C** The impact is not just on academic achievement. Malnutrition is associated with children having lower self-esteem, self-confidence and career aspirations. Malnourished children not only face direct damage to their bodies and minds, but are less confident to learn and aspire to change the situation they were born into.
- D** In the longer term, malnutrition can have a big impact on earnings when children reach adulthood. The effects of malnutrition on physical stature, the ability to do physical work, and on cognitive development, can lock children into poverty and entrench inequalities.
- E** Children who are malnourished go on to earn 20% less as adults than the children who are well nourished. But there is some evidence that the difference could be even larger – one study has estimated this earning deficit for malnourished children at 66%.
- F** This in turn means that malnutrition can act as a big barrier to economic growth. Estimates suggest that in low- and middle-income countries, the impact of malnutrition could decrease GDP by between 2% and 11%. This is partly a result of its impacts on educational development – as well as on physical productivity and health.
- G** This report presents new estimates of malnutrition's effect on GDP. By extrapolating a 20% reduction in earnings to a global level, this report shows that today's malnutrition could cost the global economy as much as \$125 billion when today's children reach working age in 2030.

- H** Investments in the potential of future generations are more important than ever before. With mortality rates falling rapidly but fertility rates declining at a lower rate, developing countries will experience an increase in the size of their working-age population in the next few decades. Many countries will have two people of working age for every dependent. This presents them with a critical window of opportunity to boost economic development, known as the 'demographic dividend'.
- I** The IMF has predicted that seven of the 10 fastest growing economies in the next five years will be in Africa. Meanwhile, economists have identified the 'Next 11' countries – those that have the potential for stellar economic growth in the next decade. A common theme in each of these countries is the potential provided by their demographic structures.
- J** But to capitalize on the demographic dividend, developing countries must invest now in the health and skills of their future workforce. Investments made now in proven nutrition interventions could increase opportunities for millions of children to become more healthy and productive members of society. The next generation of children in developing countries could fuel improved innovation, prosperity and job creation.
- K** But if we fail to make that investment the consequences could be catastrophic. Not only would that leave a future public health disaster – with a huge burden placed on health systems by a generation of people left more susceptible to disease by malnutrition – but also an economic crisis. If countries are not able to take advantage of the opportunities presented by demographic changes, then in 50 to 60 years' time they will be left with a large cohort of elderly dependents without having generated the resources to care for them.


